- Sanctioned By:** Florida Swimming of U.S.A. Swimming, Inc
- Condition of Sanction:** The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming
- Sponsored By:** Gator Swim Club of Gainesville, FL
- Type of Meet:** Outdoor, 25 yard, timed final, Age Group and Senior. Meet Management reserves the right to use fly-over starts. Coaches will be notified before the start of meet if fly-over starts are to be used.

- Pool Specs:** Outdoor pool. Certified 8 lanes, 25 yards. Eight lanes will be used for competition. A warm up/down pool will be available during the meet. Water depth at the competition starting end is a minimum of 4’.
- Timing Equipment:** OMEGA Electronic Timing Equipment. Handheld watches will also be used for backup.
- Eligibility:** Open to currently U.S.A. Swimming, Inc. registered swimmers and non-registered invited teams.
- Entry Limit:** Entries will be limited to 500 swimmers excluding the host team. A total of 5 individual events for the meet per swimmer. Swimmers over entered will be entered in the first 5 individual events.
- Scratches:** No penalty for scratching. **NOTE: DECLARED FALSE STARTS WILL BE ALLOWED IN ACCORDANCE WITH USS AND FLORIDA SWIMMING RULES**
- Rules:** Current U.S.A. Swimming, Inc. Rules govern the meet. Florida Swimming Rules & Regulations 223.10: All coaches and officials shall wear their USA Swimming registration cards in a conspicuous location at all times while on deck during the meet. Meet Referee may, at its discretion, combine heats and utilize “Fly-over” starts or chase starting procedure.
- Entry Form:** Entries must be in USA Swimming SDIF format or Hy-Tek CL2 format submitted on a Hy-Tek disk, or sent by e-mail using Hy-Tek team manager. Florida Swimming rules require a \$50.00 fee from teams that do not submit their entries in Hy-Tek format. Corrupted, unreadable, or incorrectly formatted files must be corrected within 24 hours. Errors in entries submitted electronically are the responsibility of the applicant. Email confirmation will be sent upon receipt of the file. Email to: headcoachgsc@gmail.com.

- Entry Fee:** Facility Fee- \$5.00 per swimmer
Individual Events- \$2.50
Relay Events- \$4.50
Deck Entries - \$5.00
- Deck Entries:** Deck entries are to be submitted to the head referee no later than 30 minutes Prior to the start of the meet. The fee for deck entries is \$5.00 per individual event. If the swimmer is not already in the meet, the \$5.00 facility fee is also due. Deck entries will only be placed in empty lanes and heats will not be reseeded for deck entries. Swimmers must still comply with the maximum entry limit and other eligibility requirements. Swimmers may not scratch an event to deck enter a new event.
